City Financial Revenue Needs Increasing

One of the very first items of business on my plate, other than conducting a search for a police chief and to bid out sanitation, was to figure out how Woodlawn Park could continue to offer all the fine services that we do! We have two main sources of revenue:

1) Property taxes- currently at \$.147

2) Insurance tax fees currently at 5% (*Please make sure that Woodlawn Park is listed on your insurance bill as the municipality (sometimes this might be incorrectly going to another city).*

Even with these two sources, it would have been impossible to continue to offer our police services as well as sanitation, snow removal, grounds clean up, etc. with out a change. In addition to the fine services, I have also not forgotten about the remainder of the roads that will need to be resurfaced and paved in the years to come. That would be another \$300,000. You see, Woodlawn Park did not overspend, we just were not able to save much money over the past 15 years like we had done the previous years– but, we continued to offer fine services!

The American Rescue Plan Act (the federal government response to cities for Covid-19) has provided WP with \$226,000– most of it went to our roads, a police chief increase in salary last year and now this year a few smaller items like 2 new stop signs on Beechwood Road and some police expenses.

Moving forward, my plan is as follows:

* 2023-2024 fiscal year there will be NO tax property tax 15% discount. All taxes are due in Sep-

tember.

* 2024-2025 fiscal year- add 5% property tax discount back in and increase insurance fee tax to 7%. It is currently at 5%.

By making these two changes, WP can obtain \$22,000 additional revenue in 2023-2024, and \$30,000 in 2024-2025 and the following years the insurance tax will remain at 7%.

Mayor & City Council Form of Government

Your city government is comprised of a mayor and six city council members. *Your mayor is elected every four years and your council is elected every two years.* The mayor is the executive branch and the city council is the legislative branch of the government.

REMINDERS

* **Solicitation** in the city now includes a permit issued by the Mayor. Politicians, nonprofits, the government are exempt and businesses that have a current relationship with the resident already are exempt as well.

* **NO KNOCK list** sign ups are available. If you want to be placed on the No knock list, please contact the clerk at clerk@woodlawnpark.com to sign up or simply call the city hall at 895-6620. The No Knock List is the list we give to approved solicitors in the event we issue a permit; the solicitor still could not knock your door if you are on this list. Please contact our Police Chief any time someone knocks at your door without a permit that you feel did not seem legitimate.

* By far, most of our dog walkers do a very good job of picking up after our 4-legged friends, however, from time to time, there are one or two that might be forgetting to pick up after your friends. **Please always remember to take a waste bag with you** so that if your puppy should have to stop, you will be prepared to pick up after them.

* Additionally, when walking your dog, please prevent them from entering the front yards of the residents as best you can. Along the side or a few feet is more than acceptable, however, much more than that can be a nuisance to some home owners.

Sanitation bid accepted for another 4 years!

SANITATION SERVICE bids were reviewed at the March city council meeting and Eco-Tech was chosen as our sanitation company for the next four years. Everything will remain the same as it is now.



Effective July 1, 2023, Ecotech Waste will continue serving as your trash, recycling, and yard waste needs. They are privately held and locally owned and have been in business for twenty-five years. They are fortunate to serve tens of thousands of residential customers throughout Kentuckiana. Every resident should have one 96 gallon trash container and one 64 gallon recycling container. If you require one additional container please contact customer service at 502-935-1130 to order.

Regular Garbage Pick-up: Every Monday

Yard Waste Pick up: Every Monday

Recycling Pick-up: Every other Monday (current schedule is May 22, June 5, June 19, July 3 and every other Monday thereafter)

Holidays: Ecotech observes New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, & Christmas Day. All services will be collected one day late during a holiday week. for example, if the holiday is observed on Monday the collection is pushed back one day to Tuesday.

Trash: All trash should be placed in the Ecotech 96 gallon cart. It is highly recommended to bag all trash. If an overflow of trash is generated please bag trash and place next to your cart. The maximum weight limit is 50 lbs. The following items are not acceptable: Dirt, concrete, construction material, drywall, studs, fencing, landscape timbers, large doors, windows, sinks, cabinets, swing sets, exercise equipment, patio doors, gas cans/tanks, propane tanks, oxygen tanks, and tires. NO FLUIDS OF ANY KIND ARE ACCEPTABLE including paint thinners, pesticides, and oils. No Biomedical waste hazards including needles, and chemo products.

Bulky Junk Items: You are allowed one bulk item per week to be picked up. This includes items such as washers, couches, tables, chairs, and mattresses and box springs – which need to be completely wrapped in plastic prior to collection. Refrigerators and air conditioners must have the Freon removed by a certified technician and properly tagged prior to collection. Construction, demolition, and remodeling materials are not acceptable. Two annual "junk day" pick -ups will be held, one in May and a second in October. Additionally, in other times of the year, you must telephone Ecotech customer service at 502-935-1130 to schedule a bulk pickup, preferably one week in advance.

Yard Waste: All twigs, branches, and shrubs must be 6' in diameter or less in diameter and no more than 4' in length. All yard waste bundles, bags (**no plastic bags allowed**), and containers must weigh 50 lbs. or less. Unacceptable materials include loose dirt, sod, tree stumps, complete trees that are removed, fencing, landscape timbers, and decking.

Recycling: Current materials accepted include plastics #1 thru #7, milk jugs, aluminum cans, tin cans, unbroken clear and brown glass, paper & cardboard (anything that tears such as brochures, pamphlets, posters, newspapers, inserts, magazines, cereal boxes)
